- 10. Use the HAZMAT pads to absorb any remaining neutralized spill and place used pads into the lined pail.
- 11. Place all materials used during the cleanup into the lined pail.
- 12. Place the lid on the pail and screw to lock on.
- 13. Dispose of all used articles and pail according to local, state, and federal regulations.
